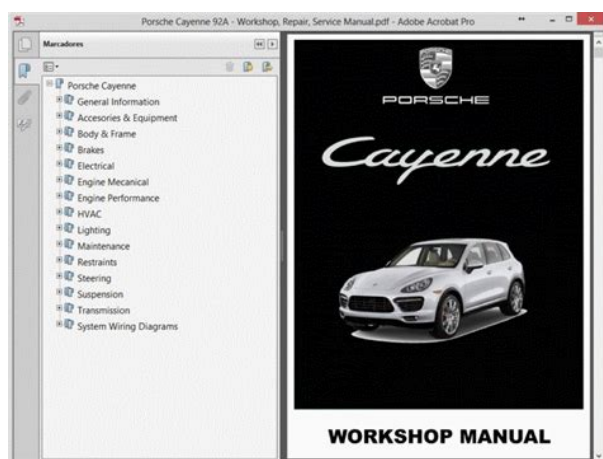

It is also Porsches first offroad variant vehicle since its Super and Junior tractors of the 1950s, and the first Porsche with four doors. Since 2008, all engines have featured direct injection technology. The Cayenne shares its platform, body frame, doors and electronics with the similar Volkswagen Touareg and Audi Q7. Later in the model cycle, VR6 and dieselpowered versions joined the lineup. Intake manifold is unique to Porsche, but otherwise engine is very similar to standard VW engine. This Porsche Design STi is also powered by an alloy 4.5L V8 engine with a drysump lubrication system and variable valve timing. It is lighter than the Cayenne S and has an aerodynamic body kit. The Cayenne Turbo and Turbo S include a lowrange case, a locking differential, and heightadjustable, offroad suspension. It is a variant with the 405 hp 302 kW directinject 4.8L V8 from the Cayenne

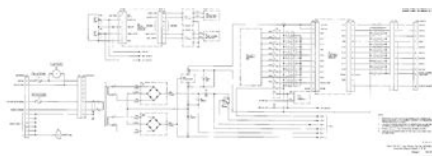

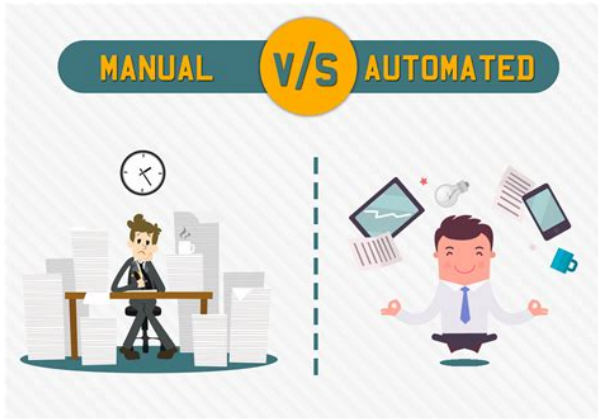
